I just recently learned, while reading a document on filing lobbying reports, that "covere officials" includes career employees of the Executive Office of the President, and not just political ones. I am therefore refiling my six-month report for Ariba to reflect two contacts with career employees of the Office of Federal Procurement Policy. While going over my records, I also decided to include in this report a contact with a non-caree official at the General Services Administration. It did not involve trying to obtain a government contract; however, I did discuss with this official the idea that GSA might wish to do a pilot project doing reverse-auctions to procure construction services, and, if GSA had proceeded along this tack, Ariba would have been in a position to compete for such a contract.
