

Dear Sir:

This letter will provide an explanation for the delay in our submitting the 1998-1999 Lobbying Report(s) to your office, on behalf of the University of Puerto Rico (UPR), as required under the U.S. Lobbying Disclosure Act of 1995.

According to notices received by the UPR Office of Federal and External Affairs, we are past due in submitting the following four reports: "1998 Year End Report;" the "1999 Mid-Year Report;" the "1999 Year End Report" and the "2000 Mid-Year Report." The reasons for the delay in submission of the above referenced reports are explained below.

Background:

• First, as the Special Assistant to the UPR President and as Director of the Office of Federal and External Affairs (OFEA), I have responsibility for overseeing the professional services of Washington, D.C. consulting firms which undertake U.S. federal agency and congressional relations work (direct lobbying activities) on behalf of the UPR. Each of these firms (Van Scoyoc and Associates and Dow, Lohnes & Albertson) submitted both Semi Annual and Year-End Reports for 1998 and 1999 on hehalf of the UPR (see copies attached).

Since the UPR-OFEA, which is located within the Office of the President of the University of Puerto Rico, has a very limited staff, the majority of our governmental and congressional relations work is carried out directly by representatives of consulting firms in Washington, D.C. retained by the UPR. Due to the continuing shortage of administrative and secretarial staff in our office and the fact that I, must travel for the University's federal and external affairs outreach programs, approximately 75 percent of my time, we have not been able to submit our reports to your office on a regular basis. In addition, due to the turnover in our professional staff this past year (Deputy Director re-assigned and new OFEA Associate Director for Federal Affairs only hired in August 1999), I was frankly not aware that we were late in submitting our reports.

Also, it is important to stress that our new staff, both professional and administrative staffs were completely unfamiliar with the lobbying registration forms and the due dates.

- Second, during the period of February-May 2000, I was hespitalized and on medical leave from the UPR. I was, therefore, unable to provide any guidance to our OFEA administrative and secretarial staff in the office on the content and procedures to be followed in submitting past due Lobbying registration forms. Since the OFEA professional staff were new, they did not have the necessary information to complete the reports during this period.
- Third, unfortunately, the UPR-OFEA has not had Administrative support staff nor an Associate Director for Federal Affairs, whose primary responsibility is to ensure the timely submission of the Lobbying Report(s) during the past two fiscal years. Previously, during the period of 1995-1998, this was the responsibility of the OFEA's last two Deputy Directors, whose position is now vacant. Please be assured that the UPR-OFEA will establish and implement the necessary administrative procedures to ensure that the reports are filed on time, even when there has not been any lobbying activity for the period reported.

Preparation of the draft reports will now be the responsibility of the Associate Director for Federal and External Affairs (Mrs. Juanita Valentin-Morris), so that the OFEA Director can submit the reports during the required reporting periods. The OFEA Administrative Secretary, Ms. Carmen Jarvis-Brookes, will assist her in meeting the required filing deadlines.

I trust that the above explanations will satisfy any questions you have regarding the delay in submission of our Lobbying Reports.
