Attached please find a copy of our amended mid-year 2005 LD-2 for the Burley Stabilization Corporation. I want to apologize for any confusion that may have resulted from filing of the 2005 mid-year report.

As you will see from the enclosed, The Bates Capitol Group timely submitted our original 2005 mid-year report for Burley Stabilization Corporation in August 2005 (signed and dated August 10th); however, this report was mistakenly marked as the 2004 year-end report thus resulting in two reports for the same client both marked 2004 year-end report.
