

Enclosed please find an amended Lobbying Report (LD-2) concerning the representation of Stoll Stoll Berne Lokting & Shlachter, P.C. ("Stoll") by Dow, Lohnes & Albertson, P.L.L.C. ("DL&A"). This amendment is in response to a letter from the Office of Public Records requesting DL&A to clarify (1) whether the income and activity reported in its August 14, 2000 LD-2 concerning Stoll was intended to cover the entire period from January 1, 2000 through the reported termination date of August 9, 2000, and (2) whether there had been any unreported activity or income.

The income and activity reported for Stoll was intended to cover the January 1, 2000 through June 30, 2000 reporting period only, since DL&A terminated its lobbying activity effective June 30, 2000, not August 9, 2000 (the date on which the original LD-2 was prepared) as initially reported. The enclosed LD-2 reflects this revised termination date. There has been no unreported income or activity with respect to DL&A's representation of Stoll.


