Advocated for support of an increase of \$3.4 billion (or 16.5%), for a funding total of \$23.7 billion in FY 2002; S.1171/HR 2311, Energy and Water Development Appropriations Act, 2002; advocated for support of an appropriation of \$3.7 billion in FY 2002 to support funding for DOE's Office of Science programs. This would be a 16% increase over last year's level for this Office; HR 2217, Department of the Interior and Related Agencies Appropriations Act, 2002; advocated for support of \$150 million in funding for the NEH in FY 2002, which would be a \$30 million or 25% increase over FY 2001 level; Department of Defense-requested \$10 million in funding to form a Center of Excellence in Biotechnology with the U.S. Army and Johns Hopkins to conduct research, testing, evaluation and pilot production in the field of biotechnology; S. 1191/HR 2330, Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations Act, 2002; advocated support for \$2.5 million for research facility construction with the Agricultural Research Service to support joint USDA-JHTJ Nutrition Studies Center;HR 2506, Foreign Operations, Export Financing, Related Programs Appropriations Act, 2002;advocated support for \$25 million for micro-nutrient research and outreach within the USAID Child Survival and Disease Programs Fund; Advocated support for \$1 million through Labor, HHS, Education and Related Agencies Appropriations Act, 2002 to continue activities of the Center for Civilian Bio-defense Studies; Together with Association of Schools of Public Health, advocated support for request of \$40 million for CDC Prevention Research Centers, through Labor, HHS, Education and Related Agencies Appropriations Act, 2002; Hopkins, with the Association of Schools of Public Health, advocated support for request of \$10 million for CDC Preparedness Center-CDC Bio-terrorism, through Labor, HHS, Education and Related Agencies Appropriations Act, 2002; Department of Veterans Affairs and Housing and Urban Development and Independent Agencies Appropriations Act, 2002;advocated support for "Living with a Star" initiative; advocated support for funding and expansion of Mars Exploration Program and other Outer Space or Deep Space missions; supported funding for Next Generation Hubble Telescope;advocated promoting the expansion of NSF funding in areas such as nanotechnology and information technology and support for development of Nanotechnology Consortium in Maryland; advocated for increased funding for the National Space Biomedical Research Institute (NSBRI); advocated for doubling the NSF budget in five years.

Stem Cell Research: advocated that current National Institutes of Health guidelines governing stem cell research remain in effect, allowing federally funded research on human pluripotent stem cells to proceed; PL104-191, Health Insurance Portability and Accountability Act: advocated through formal comment process to seek changes and modifications in proposed medical privacy rules mandated by the Health Insurance Portability and Accountability Act. Specifically, addressed regulatory scheme related to research as complex and burdensome and requested modifications in regulations on charitable contributions; S.721, Nursing Employment and Education Development Act (NEED Act); advocated for passage of bill; S.1864/HR 3487, Nurse Reinvestment Act; advocated for support and passage of bills which provide scholarship funds, public awareness and education campaigns; Labor, HHS, Education FY 2002 Appropriations bill; advocated support for continued funding for research facilities construction through the NIH's National Center for Resources Research. Supported funding in President's request of \$100 million for FY 2002; advocated support for increased funding for the health professions of \$440 million for programs provided under Title VII and VIII in FY 2002 Labor, HHS, Education Appropriations bill; advocated support for maintaining the NIH salary cap at Executive Level I (\$161,200), within the context of the FY 2002 Labor, HHS, Education Appropriations bill; HR 2178, All-Payer Graduate Medical Education Act of 2001; monitored house bill which would establish an all-payer trust fund to support Graduate Medical Education; monitored legislation in the House and Senate which would provide health care coverage for the uninsured. Congress' FY 2002 budget outline has set aside funds to address the issue of the uninsured, while Hopkins will monitor and gauge impact of proposed legislation; monitored Senate bill (Kennedy-Frist) and House bill (DeGette-Greenwood) which would increase protection of participants in human subject research. Working with Department of Health and Human Services and the Office of Human Research Protection to re-review protocols, on-going research, etc.; Contacted Maryland Senators and House Member to seek their assistance in delaying the suspension of federally supported medical research projects, involving human subjects, at the Johns Hopkins Institutions; Contacted the Office of the Secretary of Health and Human Services seeking assistance with the Office of Human Research Protection (OHRP) to delay the suspension of all federally supported medical research projects at the Johns Hopkins Institutions; S. 543, Mental Health Equitable Treatment Act of 2001; monitored and gauged impact of bill which would provide for equal coverage of mental health benefits with respect to health insurance coverage; HR 2103, Medical Malpractice RX Act; monitored and gauged impact of bill which would establish limits on medical malpractice claims, and for other purposes.
