- Russia: Asked State Dept officials to protest Russian plans to close displaced person camps in Chechnya
- Ecuador: U.S. Andean Trade Promotion and Drug Eradication Act (ATPDEA), lobby against U.S. trade benefits for country failing to comply with labor rights requirements
- China: Advocated that Congressional Executive Commission on China and US-China summit
- Pakistan: Urged US to promote democratic reforms
- Indonesia: Urged US to promote corporate responsibility and hold military accountable
- Peru: Said that US program to stop drug trade might result in civilian casualties
- Bosnia: Opposed possible US veto of peacekeeping operations
