

Pursuant to 2 U.S.C. §1605(7), this letter is to provide you with notice of noncompliance with the following requirements of the Lobbying Disclosure Act, 2 U.S.C. §1601, et seq.:

Failure to file a 2000 Midyear Amended Report to correct the following error or omission for S.C. Johnson & Son, Inc. ID #32394008:

- **Line 16 was omitted. Line 16 requires the disclosure of specific lobbying issues including bill numbers and specific executive branch actions.**
- **Line 18 was omitted. Please disclose the name of each employee who acted as a lobbyist during the reporting period; or, if no lobbyist performed lobbying activity during the reporting period, state 'None'.**

You are required by law to provide an appropriate response within **60 days** of the date of this [2 U.S.C. §1605(8)]. Failure to do so will result in referral of this matter to the **United States Attorney for the District of Columbia** for legal action. Please be advised that violators of the Lobbying Disclosure Act are subject to a **civil fine** of up to \$50,000.
