Attached please find my Year End report (July 1 - December 31, 2003) for the above client, Blood for Africa Foundation.

In preparing this report I realized that my duties since my initial filing in July of 2001 have changed considerably, but my lobbying reports have not reflected the changes in my responsibilities for this client.

When I first filed on behalf of the Safe Blood for Africa Foundation, my responsibilities were primarily working with the House and Senate with some Federal agency contact. That fact was reflected in my initial lobbying report. Since that time, especially after the first six months my duties have rapidly changed from primarily lobbying activity to primarily managerial, administrative and fundraising activities, with lobbying presently representing only approximately 25% (at most) of my work for this particular client. This Year End report reflects that change.

Please attach a copy of this letter to my record so that this change in my responsibilities can be noted for the public record and also explains the change in reported income related to lobbying on the Mid Year (2003) report from that reported on the Year End (2003) report.
