Inmarsat Inc. is a U.S. subsidiary of Inmarsat Ventures plc, a foreign corporation organized under the laws of England and Wales, United Kingdom. Its address is 99 City Road, London EC1Y 1AX, United Kingdom.

The sole shareholder of Inmarsat Inc. is Inmarsat Ventures plc, and the activities of Inmarsat Inc. are controlled by Inmarsat Ventures plc. The lobbyists included on this report, Alan Auckenthaler and Robert Demers, lobby on behalf of Inmarsat Inc. with respect to the interests of Inmarsat Inc. and Inmarsat Ventures plc.
