SPEEDY MOTION TO DISMISS

MEMORANDUM IN SUPPORT

This memorandum is supporting the speedy motion to dismiss unlawful complain of Plaintiff.

On Jan. 07 2000 at 17:20PM, unknown people were stealing my construction-built materials, tools, etc. from our house & garage which were put on the pick-up truck. At 17:30PM, I became falsely arrested, deprived liberty of individual, unlawfully searched packets by City Gahanna police forces. On 08 Jan. 2000, I had a court trial before judge Haynard in Case No. 2000 CR 675 and bond of \$3000 was assigned. My wife paid \$341 and I became released about 0940PM on Jan 08, 2000. On Jan. 14, 2000 the Court dismissed the false charge - judge Brandt was on bench. On Jan 27, 2000 at 700PM, I was falsely arrested in Hotel in Whitehall with the same brutal practice (handcuffing, searched my pocket, deprived liberty of individual. On 28 Jan. 2000, Judge Taylor ordered second unlawful bond of \$3520 paid to bondsman for the same false charge on Jan. 07, 2000. The complaint intentionally has a false address of Andrew G. Zukowski at Streets of Columbus. My wife and me were in Hotel in Whitehall thanks to Catholic organization. Judge Taylor ordered for mental treatment as well. However I strongly protested against that communistic method that try to make an intelligent and bright, advanced educated Master Science of Electr. Engineer, a mental ill and ordered to psychiatrists.

Hospitals. This is a shabby conspiracy to deprive me rights to run for Federal office to the United States House of Representative from 12 Congressional district Ohio. "The Due Process Clause of the Fourteenth Amendment protects the accused against conviction except upon proof beyond a reasonable doubt of every fact necessary to constitute the crime with which he or she is charged." On Feb. 01. 2000, I filed the SPEEDY MOTION TO CORRECT UNLAWFUL BOND AND RELEASE TO CONDUCT MY PRIMARY COMPASSION 2000 for primary election on March 07. 2000. I did not get any decision so far. On Feb. 02. 2000, I had a conversation with Counsel Eric at FCCC and he assured me about my confident mental condition. On Feb. 03. 2000, I was talking with Dr. Hoelman from Franklin County and strongly opposed to mental treatment as prohibited communistic method. On Feb. 07. 2000, I had a court trial before judge Hayes. Trial got a continue status with recommendation for mental treatment. I strongly protested to attorney Melissa Bedell against that unneeded prohibited mental treatment. On Feb. 08. 2000, I had, against my good will and faith, a conversation with S.C. Khelef, PhD Clinical Psychologist on order issued by judge Taylor. I was astonished and said that do not act under duress to sent me for mental treatment. I am confident that do not need any mental conditional treatment. I am a Master Science in Electrical Eng, federal dominating powerful electrical engineer of DSCC part of Department of Defense, family advocate

Pro-se. to protect my family life, real state, property, personal property, etc. to live in dignity and integrity as millions Americans families. My wife and I have been registered Lobbyists to the U.S. Congress with out of payment to protect minority groups civil rights, stop a hate crimes against them, stop persecution on all bases which are guaranteed by the United States & Ohio Constitutions, and U.S. Codes Title 5, Title 18-Chapter 13 and accepted by Ohio state. On Feb. 11 and 23, I had a court appearance before judge S. Hoyer. however I did not be in Court Room 12B because attorney Phil Churchill and second time deputy sheriff said: "you are not needed be there."

On Feb. 17, 2000, I filed second speedy motion to stop unlawful practice and release to my lovely wife - Teresa. My wife was in this Court at morning and she got wrong information that will not be my trial this day 23 of Feb. 2000. Who is doing this cheating practice and why? 1. I have personal knowledge of the facts stated herein.
2. I am competent to testify to the matters contained herein.

5. On December 4, 1996 at approximately 2:30 p.m., I was dispatched to Building 308 at the DSCC to the office of Mr. Ron Dashner, DSCC Facility Engineer. Upon my arrival, Mr. Dashner explained that a Notice of Proposed Removal and a letter of debarment from DSCC were to be issued to Mr. Andrew Zukowski. 
