During the reporting period, Registrant received from Client non-qualified stock options for 450,000 shares of Client and exercised 450,000 of those stock options. The value of the shares of Client at the time Registrant exercised such options was \$1.95. Therefore, when such value is rounded to the nearest \$20,000, Registrant received income of approximately \$880,000.00. The balance of the stock options were not exercised during the reporting period.


