Your letter dated July 29, 2003 (copy attached), discussed omissions from the 2002 Year End Report filed by Medtronic, Inc.


After reviewing our report, I noticed that a page was included for the general issue area of budget/appropriations. Our organization did not lobby in that general issue area and this page should not have been included.


