
Thank you for your letter of April 28th regarding “Notice of Noncompliance” and for bringing our attention the failure to file the 2001 Midyear Semi-Annual Report.

Please be advised that our records reflect that we mailed the required LD-2 Form on or around July 16, 2001. Our records also indicate that a “Notice of Receipt” for the 2001 Midyear Semi-Annual was also not attached to our file copies confirming delivery by the Office of the Clerk that we routinely receive by your office and attach to our file copy. A further review of our file indicates that we also do not have “Notice of Receipt” for the 2001 Year-End that should accompany the LD-2 file copy that we filed on or around December 7, 2001. The Year-End 2001 filing also indicated our termination of the Stevens Institute of Technology effective December 31, 2001.
