

ATTACHMENT A

Cruden Investments Pty. (incorporated in the State of Victoria) has a voting interest in approximately 30% of The News Corporation Limited ("News Corp."). News Corp., which is incorporated under the laws of the State of South Australia, indirectly owns a number of entities operating in the United States, including all of the stock of News America Incorporated, which is incorporated in Delaware. News America Incorporated indirectly owns partial interests in a number of U.S. entities, including approximately 81% of the stock (constituting approximately 97.8% of the vote) of Fox Entertainment Group, Inc., which is incorporated in Delaware.
