Natsource LLC ("Natsource") recently completed an internal review of its compliance with the reporting requirements of the Lobbying Disclosure Act ("LDA"). As we discussed on March 21, 2005, this review indicated to Natsource's management that a number of reports of Natsource's lobbying activities on behalf of the above-referenced clients appear not to have been received by the Secretary of the United States Senate, and/or contain certain information that requires correction.

We determined that several reports, while apparently not received by the Secretary of the Senate, were, in fact, however, received by the Clerk of the United States House of Representatives. These reports are as follows.

(The House ID numbers on these reports, however, match the House ID numbers on the Natsource registrations for the respective clients; no Senate ID numbers appear on the reports.)
