Legislation of interest includes the Farm Security and Rural Reconciliation Act of 2001 (H.R. 2646), the Emergency Agricultural Assistance Act of 2001 (H.R. S. 1246), the FY 2002 Agriculture Appropriations Bill (H.R. 2330, S. 1191) and the Agriculture Appropriations Act (P.L. 106-387).
